#### C. Welcome to Visitors and Public Participation

- Linda M Kimble shared that she hopes the board responds to the letter from NARF.
- Kathy McMahon Klosterman shared that she hopes the board will address the concerns about the THS mascot. She shared the code of ethics from ODE, and indicated she hopes that the board is keeping this code in mind while making decisions.
- Tammy Ironstrack who is a parent of 3 students in Talawanda Schools and would like the board to address the concerns about the THS mascot. Her family are members of the Miami tribe and she is concerned about harm to her own children.
- Janice Dutton shared that she is concerned about the 'tradition" Talawanda is keeping with the current mascot, and she indicated that the current

mascot has become outdated and she gave some examples of how traditions have been moved away from when appropriate and when things become outdated or new information is available.

- Kristina Shepherd requested help and guidance for her son Gunner (Bogan student). He is struggling in school with reading and behavior. He has been diagnosed with 8 different disorders. They have requested her 4th grader be retained for the help he needs. She has recommendations from Children's Hospital and his therapist that have been provided to TSD. She is concerned about the lack of support she is receiving from the principal, and his refusal to honor the request she has made and has been supported by her child's medical staff. She is concerned about a new teacher and new EA, as her son does not transition well. She would like to have her request considered.
- Holli Morrish thanked Mrs. Spivey for her service for the past 15 years in Talawanda Schools.
