- A. Butler Technology & Career Development School Report Mr. Meade
 - Butler Technology Slide Show (on screen).
 - Participation has been fairly consistent during the past 6 years.
 - The distance might be one impact to greater participation numbers.
 - The science center at BT is popular.
 - Quite a few satellite programs between THS and one at TMS. Vo-Ag is very popular.
 - CBI has changed in the number of programs available during the past few years.

- B. Legislative Liaison Report Dr. Knight-Abowitz
 - Governor DeWine is working on a bill that deals with the issues associated with the pandemic/shut down. This impacts funding. It has some parts regarding student religious expression. It also prohibits schools from NOT promoting third graders regarding the third grade test. Also has provisions for telecommunications for special education, and prohibits schools from furloughing teachers. Mrs. Tafelski indicated she believes we may receive back \$14K.

C. Arts & Athletics Liaison Report - Dr. Howard

• Athletics wirth limited contact and conditioning is going very well. Students are very happy to be back. OHSAA has been vague about upcoming rules for Fall. Regarding the Arts...marching band is not starting training/skills yet. They are waiting for new guidelines. Percussion and color guard are also waiting until July. All guidelines will be followed when students can return to activities.

D. Student Achievement/Academic Liaison - Mr. Otto/Dr. Roberts

• Dr. Roberts sent a monthly bulletin with information regarding opportunities happening around the state. It helps to keep BOE's and administrators "in the know" about state activities.

A. Pride Data Presentation - Amy Macechko

- The Health Coordinating Council is active in this and helps with non-academic barriers to learning.
- The survey is offered to all 7-12 students back in November 2019. 989 students participated. The survey looks at alcohol, tobacco, and other drugs. This year they included mental/social/emotional health issues.
- Since 2006, we continue to see a reduction in use over time.
- TSD students usage is lower than county and regional stats.
- Most TSD students are NOT using substances...this is good news!
- E-cigarettes are the new drug of choice however.
- Age of first use in our community is 13.5 in this community, and those who use...do it mostly at home or a friend's home. They get this from friends and sometimes parents.
- Being involved in positive activities reduces the risk of using.
- Dr. Howard wants to increase training for adults to reach out to students, and Dr. Knight-Abowitz is pleased to see the district equity plan also included in this work. Dr. Roberts shared she likes all of the collaboration with community agencies.
- It takes a whole community to raise healthy young people!
- Dr. Theroux shared his thanks for this work.

- Mr. Hubbard is sharing maps of the district owner properties, sharing year built, sq. ft/acreage, and facility updates.
- Mr. Hubbard shared details about the train station and also the BC Regional Transport Authority that is being planned.

 - TSD has a 4 year device cycle. The devices we have can last 4-6 years...at the end of that time automated updates will expire and then we could not do testing.
 - Postponing the cycle purchase could be an issue because the buildings take turns in the cycle, and then next year we would have to double the purchase which is not included in the IT forecast.
 - Presently devices are still with students.

- When devices are returned we send the best ones to the school loaner program, and then the remainder goes to a buy-back program.
