C. Welcome to Visitors and Public Participation

- Amy Shaiman, Kramer parent, shared information regarding the research of continued use of Native American mascots and how this harms both Native American students and other students. She is aware that our vision statement uses the word "empower", and she asks our district to rise to this. She is concerned that this representation of "pride" should no longer continue and she requests that TSD move away from the current mascot image.
- Kathy McMahon-Klosterman, district resident, and she reminded the board that the district
 has been informed of harm that occurred to a Native American student in the past, and that
 a current Native American student has indicated that he does not want participate in
 activities that uses the current mascot. She encourages the district to stop using the current
 image.
- Ashley Engle, MU student, and she is representing a university student group, interested in bringing support to our students examples like...ACT/SAT prep, city trash pick up, carnivals...etc. They hope to forge a bond and positive relationship with community members. There is a scholarship available for TSD students.

- Ann Wengler, district resident, she is concerned about the use of the Native American mascot, and she urges to district to move away from the current mascot. She shared a personal story regarding her daughter who has since passed away, but was African American, and had special needs, She shared a story of how her daughter suffered some poor treatment during her school years. She also shared that her other daughter (and friends) brought forward some research that was provided to the board, and she is now asking the board to reconsider the use of the current mascot.
- George Ironstrack, local resident, and member of the Miami Tribe of Oklahoma, he shared information regarding research about the harmful impact of the use of Native American mascots. He urges the board to take the recommendations they have been given. He is worried about students "not belonging".
- A community member shared- "American Indians mascots, considered racist propaganda, cannot continue." She shared her personal story as living in our society and being "mocked" due to her race. She wants Talawanda to make a change.
- Linda Musmeci-Kimble, district resident, she shared some research regarding "intent" when doing things. She is worried about labeling people as "trouble-makers" to people who are interested in motivating change regarding the use of the current mascot. She quoted Dr. Piardi. She is worried that we are "tolerating and desensitizing" our children in our schools.
- Janice Dutton, district resident, interested in minutes and miscommunication, she would like meetings to be taped and shared with the public. She shared information regarding what she declared was a mistake in the June minutes. She is concerned about the civil rights of children.
- A resident is thankful for the opportunity to speak and hear others, but he is concerned about the Native American mascot. He wanted to know if the board is aware how many Native American students are in TSD. He reported its less than 5%. He is concerned that the current mascot is not well represented to know or understand what a "Brave" is...students are left to believe what they might learn from television. He indicated that some organizations may not want to do business with a school district that has a Native American mascot.
- Shawn Vanness, alumni, and TSD resident is concerned that the district is valuing tradition over inclusion. She is worried about bigoted behavior. She would like the board to stop using the current mascot.
- Hugo, TSD resident, he reported he knows what it is like to be a minority. He is concerned about the current image used as the mascot. He feels the image is grotesque.

• The coalition has been awarded a \$75K grant from the state of Ohio to be focused on youth drug/alcohol prevention. The programming will include both TSD and MU. The goal is to identify gaps, create a youth led prevention plan, and create a network within the community. There is a goal to expand the "PAX" plan and this is currently being delivered at Bogan & Marshall. The hope is to approve a supplemental person to help with this in TSD.

- SB216 addresses issue with OTES, and career readiness, and college prep requirements. The CCP language regarding cost of textbooks is changing.
